Set-up will be Friday, 18th from 9:00 am- 2:00 pm (see Consignor Drop Off schedules). Tables are assigned based on when your payment is received, first-come, first served. Look for the table with your company name on it. The hours for the event are as follows:

Saturday, March 19 th	7 am - 5pm
Sunday, March 20 th	7 am - 3 pm (50% OFF Sale)

- You are solely responsible for manning, operation, setup and breakdown of your booth. All booths must begin breaking down at 3pm on Sunday, March 20th when the sale ends. Although we recommend that your booth be manned throughout the event, this decision is left solely to your discretion.
